Dear Health Care Provider,

Please read the enclosed material in order to determine if any of your patients are eligible to apply for funding. You must fill out the physician form and the parent/guardian must fill out the other forms, <u>but all forms must be submitted through your office to the Lyme Disease Association, Inc. (LDA).</u> Note that new documentation may now apply. All checks will be payable to your practice. If you know of anyone willing to donate to the LDA to help children get diagnosed/treated for Lyme disease, please let them know about the LA4K program. Thanks!

Enclosed is a packet of material regarding the Lyme Disease Association's (LDA) fund, LymeAid 4 Kids (LA4K). The fund will provide monies for families who have no health coverage for their children or no healthcare reimbursement for Lyme disease and cannot afford to get their children diagnosed or treated for Lyme disease. The fund permits awards up to \$3,000 per child to be used for diagnosis and treatment—funds which are applied for through the child's provider.

LDA created the fund in collaboration with internationally acclaimed, New York Times best-selling author Amy Tan, whose work, "The Opposite of Fate: A Book of Musings" includes a chapter on her fight against Lyme disease, including her difficulty in getting diagnosed. To date, LDA has awarded ~\$420,000 in assistance to families for their children.

We hope that you will use the enclosed information to determine if you have a patient who is eligible for LA4K and agree to help the family apply for the monies.

Please display the LA4K notice in your office to alert eligible families or potential donors about this fund.

Parameters of the LymeAid 4 Kids Fund



- Applicants are eligible to apply for up to \$3,000 for children under the age of 21.
- > The applicant shall possess neither medical insurance coverage for Lyme disease nor receive government assistance for medical treatment for Lyme disease. However, if the applicant has any existent private or government coverage which will not pay for the services of a provider who treats chronic tick-borne disease for which the applicant is applying, that should be noted on the application and the application can still be considered for possible approval if all other conditions are met.
- > The applicant/guardian must sign a statement waiving medical privacy.
- > The applicant/guardian shall sign a certified statement testifying to financial hardship.
- > The applicant/guardian shall have a signed & dated provider recommendation that the applicant/guardian is suffering from financial hardship, and that based on symptoms and history, Lyme & other tick-borne disease testing and/or treatment is necessary.
- > All forms must be submitted by the doctor's office to the LDA. Families fill out their form and give it to provider. NO forms will be accepted directly from patients, only through the submitting office. Send to: LA4K@LymeDiseaseAssociation.org or Lyme Disease Association, Inc., PO Box 1438 Jackson, NJ 08527
- ➤ When corresponding with the LDA via email, fax, or postal mail **must** include provider name, office designation, and phone contact.
- > Patients must be U.S. residents.
- > Treating healthcare providers must be US residents and licensed in the US.
- > A patient may receive a LA4K award only ONE time.
- > Families can only submit an application from one doctor for a particular child. Can submit for other children.
- > All LA4K checks will be payable to the submitting provider's office only. LA4K Checks cannot be made payable to labs, pharmacies, or other medical entities.
- > Money may be used for determining if patient has Lyme disease or for treatment by & in submitting office.
- LDA retains the right to obtain tax records & medical bills of applicant and/or guardian & his/her spouse.
- > LDA retains the right to be reimbursed by applicant if application statements are proven false at any time.
- The LDA is not responsible in any way for medical treatment received using LymeAid 4 Kids funds.
